

Slide HitClip Single into Boombox.




Press the Play button to start and stop music.

Carefully place earplug into ear.




Press the Play button to start and stop music.

 Press the Scan button to electronically scan for the strongest FM radio stations.



Push the Reset button to return to the bottom of the dial.

# Battery Replacement Rock Micro Boombox


1. Your Rockin' Boombox comes with batteries already installed.

2. Per diagram, unscrew 4 battery door lock.

3. Remove exhausted batteries and dispose of.

4. Insert 3 new AAA/LR03 batteries.

Replace batteries door and tighten screw.



#### **Battery Replacement** Personal Player

1. Your Micro Personal Player comes with batteries already installed.

Per diagram, unscrew battery door lock.

Remove exhausted batteries and dispose of.

4. Insert 3 new LR44/G13A type Button Cell.

5. Replace batteries door and tighten screw.


