


Beat Bot 6000™ Instruction


Includes: Beat Bot 6000™ HitClips™ Player HitClips™ Micro Music Clip



Play/stop button:
 Press the Play button to Start/Stop the HitClip music.

2. HitClips™ music slot: Insert the HitClip here.

- 1. Dance
- 2. Music 3. Off



WARNING: CHOKING HAZARD - SMALL PARTS. NOT FOR CHILDREN UNDER 3 YEARS.

The Mode Select Button is located behind Beat Bot 6000™'s head. By default this button is set to the DANCE mode. Beat Bot 6000™ will dance when a HitClip is inserted and played.


You could move the button to the MUSIC position. In this mode, Beat Bot 6000™ Will not dance. Only the HitClips™ music will be played.

To turn Beat Bot 6000^{TM} off, move the button to the OFF position.

To play a litelips™ Micro Music Clip

Carefully insert the HitClips™ chip into the slot. Play and stop by pressing the Play/Stop button. When in dance mode, Beat Bot 6000 will automatically dance to the sound of the HitClip. If Beat Bot 6000™ is in MUSIC mode, only the HitClips™ music will play.





- 1. Unscrew battery door. (see diagram)
- 2. Remove used batteries and dispose of properly.
- 3. Insert 3 new AA/LR6 batteries.
- 4. Replace batteries door and tighten screw.

To ensure proper function

- · Do not mix old and new batteries.
- Do not mix alkaline, standard (carbon zinc), or rechargeable batteries (nickel-cadmium).
- · Batteries installation should be done by an adult.
- Non-rechargeable batteries are not to be recharged.
- Rechargeable batteries are to be removed from the toy before being recharged (if removable).
- Rechargeable batteries are only to be charged under adult supervision (if removable)
- Only batteries of the same or equivalent type as recommended are to be used.
- Batteries are to be inserted with correct polarity.
- Exhausted batteries are to be removed from the toy.
- The supply terminals are not to be short-circuited.
- Do not dispose of batteries in fire as batteries may explode or leak.

90-pay Limited Warranty

Tiger Electronics (Tiger) warrants to the original consumer purchaser of this product that the product will be free from defects in materials or workmanship for 90 days from the date of original purchase. This warranty does not cover damages resulting from accident, negligence, improper service or use or other causes not arising out of defects in materials or workmanship.

During this 90-day warranty period, the product will either be repaired or replaced (at Tiger's option) without charge to the purchaser, when returned with proof of the date of purchase to either the dealer or to Tiger.

Product returned to Tiger without proof of the date of purchase or after the 90-day warranty period has expired, but prior to one year from the original date of purchase, will be repaired or replaced (at Tiger's option) for a service fee of U.S. \$10.25. Payments must be by check or money order payable to Tiger Electronics.

The foregoing states the purchaser's sole and exclusive remedy for any breach of warranty with respect to the product.

All product returned must be shipped prepaid and insured for loss or damage to:
