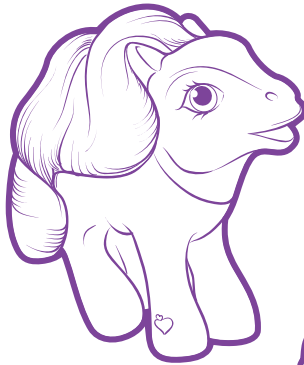

Batteries included. Replace with 2 x 1.5V "AAA" or R03 size batteries. Alkaline batteries recommended. Phillips/cross head screwdriver (not included) needed to replace batteries.

Includes SWEETBERRY pony figure, birthday cake with candle, 2 slices of cake, 2 forks, 2 party hats, 2 invitations, paper garland, gift box and comb. Pony's foot contains magnet.



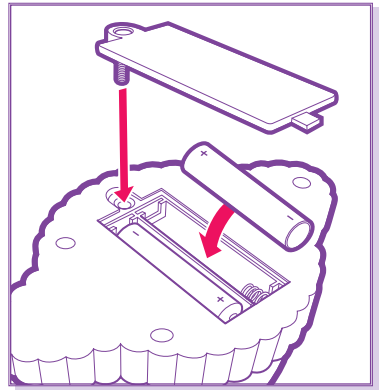
# PLAYTIME

To hear birthday song, touch heart on cake platter with front foot of pony figure.



## TO REPLACE BATTERIES

Use a Phillips screwdriver to loosen screw in battery compartment door (screw remains attached to door). Remove door and remove old batteries. Insert 2 x 1.5V fresh “AAA” or R03 size batteries. Alkaline batteries recommended.



### CAUTION:

- 1) As with all small batteries, the batteries used with this toy should be kept away from small children who still put things in their mouths. If they are swallowed, promptly see a doctor and, in the U.S., have the doctor phone (202) 625-3333 collect, or, in Canada, have the doctor call your provincial Poison Control Centre.
- 2) Make sure the batteries are inserted correctly and always follow the toy and battery manufacturers' instructions.
- 3) Do not mix old batteries and new batteries or alkaline, standard (carbon zinc) or rechargeable (nickel-cadmium) batteries.

## IMPORTANT: BATTERY INFORMATION

Batteries should be replaced by an adult.

### CAUTION:

- 1) Always follow the instructions carefully. Use only batteries specified and be sure to insert them correctly by matching the + and – polarity markings.
- 2) Do not mix old batteries and new batteries, or standard (carbon-zinc) with alkaline batteries.
- 3) Remove exhausted or dead batteries from the product.
- 4) Remove batteries if product is not to be played with for a long time.
- 5) Do not short-circuit the supply terminals.
- 6) Should this product cause, or be affected by, local electrical interference, move it away from the other electrical equipment. Reset (switching off and back on again or removing and re-inserting batteries) if necessary.
