STOCK EXCHANGE

When a player lands on STOCK EXCHANGE, he has the Option of buying from the Bank, one* Share of Stock in any Company he prefers, at the Par Value Price, printed on the Stock Certificates. If a Player wishes to buy, he pays the Bank for the Stock and receives a STOCK CERTIFICATE in the Company he selects. If the Player declines the Option, the Banker immediately offers this OPTION for sale at Auction and sells it to the Highest Bidder.

STOCK

Original purchases of Stock can only be bought from the Bank, one* Share at a time, when some player lands on STOCK EXCHANGE. Stock can be mortgaged at one-half the Par Value Price, or can be sold to any Player as a private transaction for any amount that the Owner can get.

DIVIDENDS

Dividends are payable by the BANK to All Stock Holders upon any Token landing on STOCK EXCHANGE, in accordance with the list printed on the Certificates held by the Owner.

It is an advantage to own the entire block of Stock of a Company, as the Dividends increase considerably with the amount owned in any one Company.

NOTE: "STOCK EXCHANGE" Space on a "MONOPOLY" Board is that Space designated as "FREE PARKING".

Place the STOCK EXCHANGE on that Space on Your Board, insert the Pink and Yellow Cards In Packs, and proceed with the Game in accordance with the Rules.

*Some Players like to be able to purchase one or two Shares of Stock at a time. This may be done if agreeable to all Players, before starting the game.


