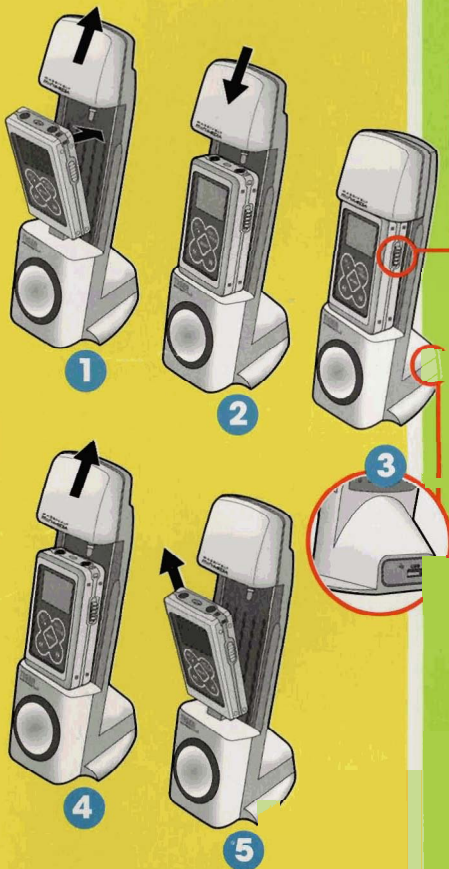

on/off switch

- 1 Slide the Docking Station top up and insert your massively mini™ MEDIA player bottom first, lining up the USB port.
- 2 Slide the Docking Station top down and snap it into place, making sure the headphone jack lines up with the player.
- 3 Use the USB cable/AC Adaptor to connect the Docking Station to either an electric outlet or a computer, for viewing or charging. Switch your massively mini™ MEDIA player on, using the on/off switch on the side of the player. Adjust volume and choose functions on the player.
- 4 To remove the player, slide the Docking Station top up...
...and gently lift the player up, then out, as shown.

If your massively mini™ MEDIA player is in the Docking Station, connected either to an electric outlet or to a computer, it will recharge, even when not turned on. The player will also recharge during use.
