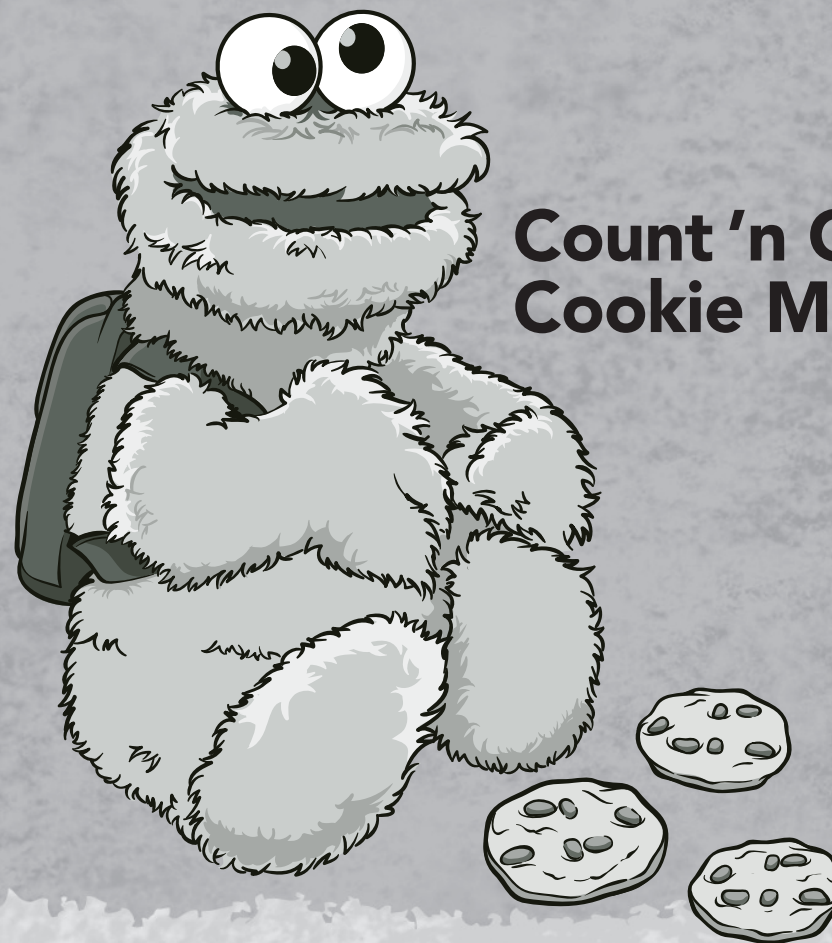

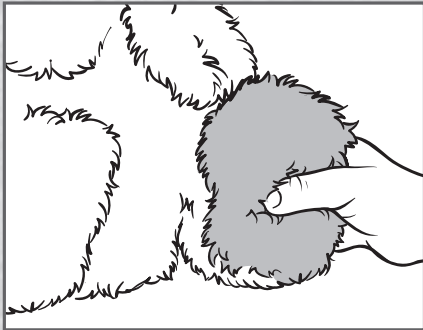
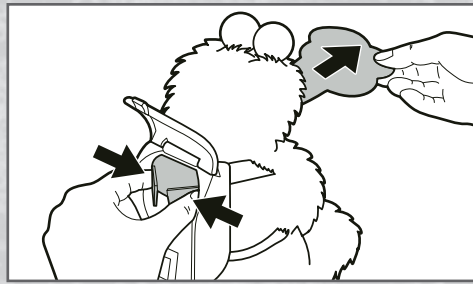
## **BATTERIES INCLUDED**

Replace with 4 x 1.5V "AA" or R6 size batteries.  
Alkaline batteries recommended. Phillips/cross head screwdriver (not included) needed to replace batteries.



## Note to Consumer:

Cookie Monster comes with a cardboard cookie in his mouth. Please discard cardboard cookie.



## TO PLAY:

To activate Cookie Monster, press his left foot. Cookie Monster will ask for a cookie. Place a plastic cookie in his mouth to see him “eat” it. When he is finished “eating” it, he will count it. Continue to feed Cookie Monster. He can count up to three cookies. He also sings a fun song about counting cookies.



Cookie Monster also likes to laugh. To hear Cookie Monster giggle, press his foot repeatedly.

**Sing along with Cookie Monster!**  
**Here is what he sings:**

Me count cookies,

1-2-3.

Yeah, won't you please count along with me?

Cookie Monster's cookies fit neatly in his backpack for storage

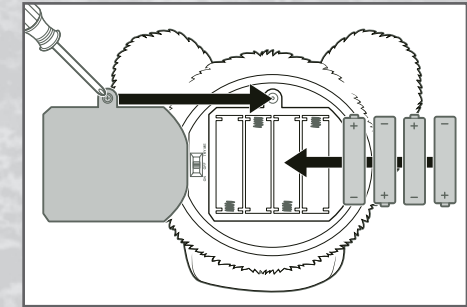


## Troubleshooting:

If Cookie Monster is not working, make sure to move the ON/OFF switch from TRY ME mode to the ON position. If he still does not work, replace batteries.

## TO REPLACE BATTERIES:

Use a Phillips/cross head screwdriver (not included) to loosen screw in battery compartment cover (screw remains attached to cover). Remove cover. Remove and discard old batteries. Replace with fresh 4 x 1.5V “AA” or R6 size batteries. Alkaline batteries recommended. Replace cover and tighten screw.



## IMPORTANT: BATTERY INFORMATION

### ⚠ CAUTION:

1. Always follow the instructions carefully. Use only batteries specified and be sure to insert them correctly by matching the + and – polarity markings.
2. Do not mix old batteries and new batteries or standard (carbon-zinc) with alkaline batteries.
3. Remove exhausted or dead batteries from the product.
4. Remove batteries if product is not to be played with for a long time.
5. Do not short-circuit the supply terminals.
6. Should this product cause, or be affected by, local electrical interference, move it away from other electrical equipment. Reset (switching off and back on again or removing and re-inserting batteries) if necessary.
7. RECHARGEABLE BATTERIES: Do not mix these with any other types of batteries. Always remove from the product before recharging. Recharge batteries under adult supervision. DO NOT RECHARGE OTHER TYPES OF BATTERIES.
