1. Turn cash register upside down.
2. Use a Phillips/cross head screwdriver (not included) to loosen screw in battery compartment cover (screw remains attached to cover). Remove cover.
3. Remove and discard old batteries. Replace with 2 x 1.5V "AAA" or R03 size batteries. Alkaline batteries recommended.
4. Replace cover and tighten screw.

IMPORTANT: BATTERY INFORMATION



CAUTION:

1. As with all small batteries, the batteries used with this toy should be kept away from small children who still put things in their mouths.
