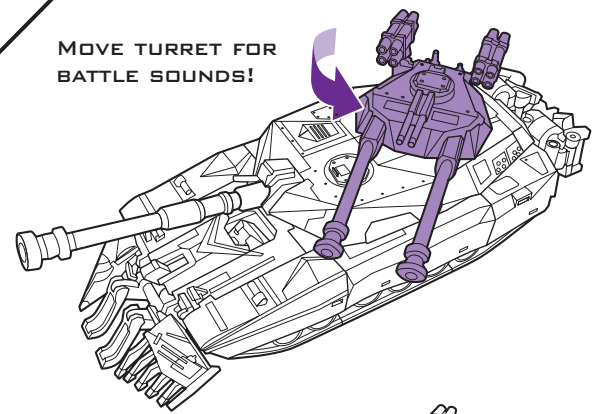
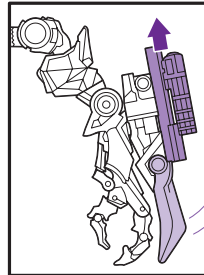
REVERSE ORDER OF INSTRUCTIONS TO CONVERT BACK INTO ROBOT.



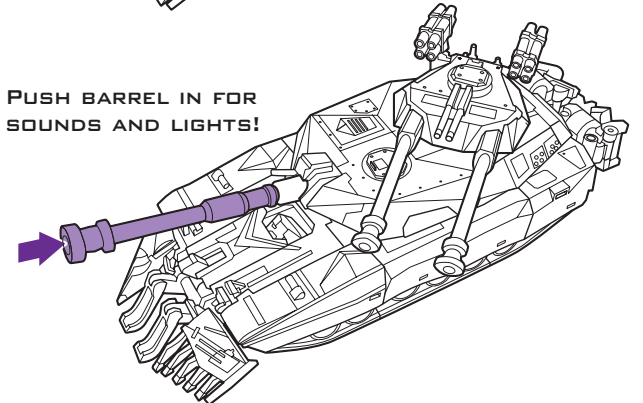
**AUTOMORPH

**EXTENDING ARM BLADE!**



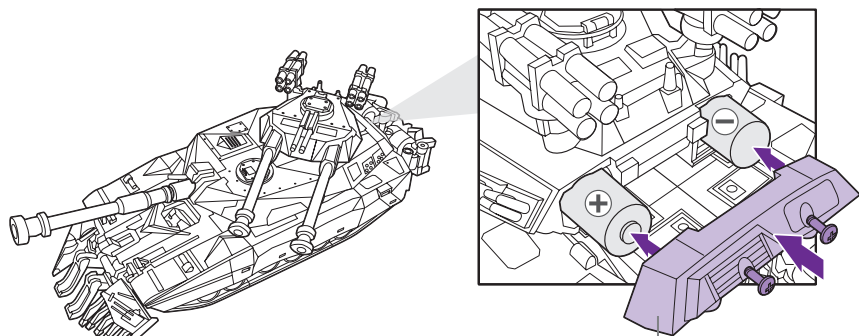
**MOVE TURRET FOR

### TO REPLACE BATTERIES:

Use a Phillips/cross head screwdriver (not included) to loosen screws in battery compartment door (screws remain attached to door). Remove door and discard old batteries. Insert 2 x 1.5V fresh "AA" or R6 size batteries. Alkaline batteries recommended. Replace door and tighten screws.
